The Carroll County Election Commission announces VOTING for the County Primary, May 5, 2026. Registered voters, in Carroll County, may cast a ballot on Election Day by personal appearance at their designated polling location.

State law requires voters to present a Federal or State government issued photo ID to vote, unless an exception applies. College student IDs will not be accepted. This photo ID requirement includes Early Voting and Election Day at your assigned polling place.

EARLY VOTING FOR THE MAY 5, 2026 PRIMARY will be Wednesday, April 15 through Thursday, April 30. Weekday voting will be 8:30 a.m.-4 p.m. Saturday voting during Early Voting will be April 18 & 25, 9 a.m.-12 p.m. NOON.
